- **Rules:** NYS High School Modified Bout Lengths 1 minute periods for all novice and advanced 6U, 7-8, 9-10, 1:30 minute periods for 11-12 and 13-14.
- All groups will be assigned to one mat
- **AWARDS:** Custom wood engraved plaques for first and second place advanced and medals for 3rd and 4th place, Medals for Novice 1st – 4th Place
- **AWARDS** given to top 3 teams – 10 man roster submitted prior to start of advanced groups and only advanced entries can count towards the roster – No combining teams
- Singlet and Headgear preferred, no loose clothing
- Sudden death overtime, 1 minute then 30 seconds
- No JV or Varsity experience
- Novice & Advanced will be Madison Pair System- Round Robin
- Wrestlers may only enter one weight-class and division (to be determined)
- Random weight checks will be done, any wrestler weighing more than 2lbs over their registered weight will be moved up to the next group if there is room – otherwise the wrestler will be disqualified with no refund
