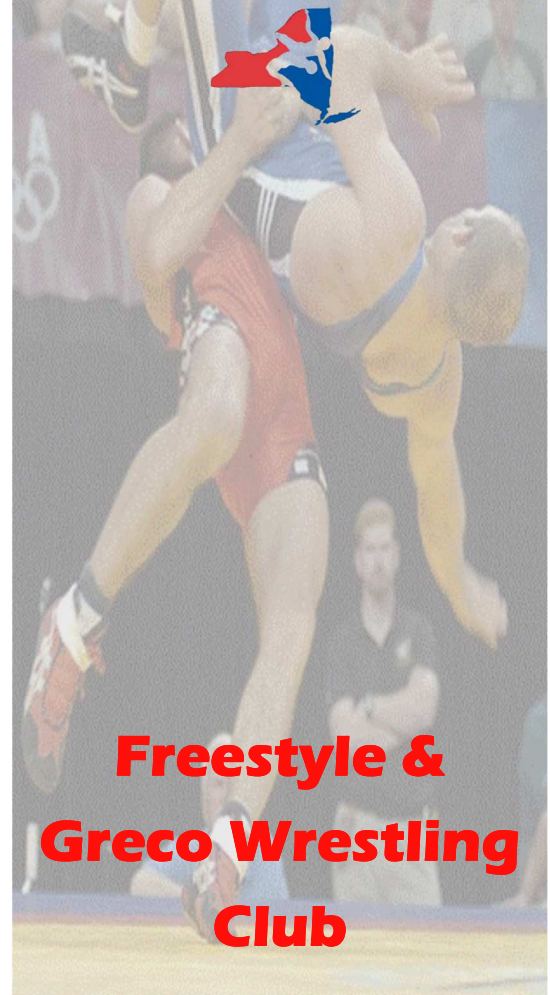

MVWC ATHLETE CODE OF CONDUCT

As a wrestler with Mohawk Valley Wrestling Club, you will be representing yourself, your family, our club, your school/community, New York State, USA wrestling and the United States of America. It should be stressed that the MVWC membership is a Privilege, not a Right! As such, the Board of Directors of MVWC believes that each wrestler should assume responsibility for their own behavior, and should be accountable for their actions on and off the mat. Therefore, all wrestlers shall abide by all applicable laws, rules and regulations of the State of New York, USA Wrestling and any state or foreign country in which the wrestler may be traveling with the club. While engaged in any competition, practice, or other event in which MVWC is involved, including travel to and from with the club, wrestlers shall comply with the following prohibitions:

1. No use of or possession of drugs deemed illegal by the State of New York
2. No drinking of alcoholic beverages by wrestlers under the age of 21, regardless of legal age in country in which we are in
3. No use of tobacco (chewing, smoking or snuffing)
4. No stealing, tampering with, or destruction of belongings/property of others including practice and tournament sites

Violation of the preceding will result in the Board of Directors canceling the wrestler's membership with MVWC. In the event of cancellation there will be no refund of registration. Suspected violations can result in immediate suspension. However, an appeal by the wrestler and his parent/guardian or coach will be heard by the B.O.D. before making their final decision. Ultimately, the B.O.D. reserves the right to refuse or revoke membership to any wrestler who fails to comply with the MVWC rules and policies, be they written or verbal.
